Colonel Counihan, USAR, is the US Army Reserve Senior Policy Advisor to the Chairman of the Reserve Forces Policy Board (RFPB) in the Office of the Secretary of Defense, Washington, D.C. The Reserve Forces Policy Board serves as an independent adviser to the Secretary of Defense, providing advice and recommendations to the Secretary on strategies, policies, and practices designed to improve and enhance the capabilities, efficiency and effectiveness of the seven Reserve components.

Colonel Counihan (originally from Norwich, CT) received his commission as a Transportation Officer from the University of West Florida in 1995. He is a graduate of the Transportation Officer Basic

Course (Distinguished Graduate), Transportation Officer Advanced Course, Combined Arms Exercise Course (CAX), Advanced Force Management Course, Career Manager Course, Logistics Executive Development Course (LEDC), Intermediate Level Education-CGSC (ILE-CC), Defense Strategy Course, Basic Strategic Arts Program (BSAP), Advanced Operations Course (ILE-AOC), and the Joint Advance Warfighting School (JAWS).

His active duty assignments include: Platoon Leader, 360th Transportation Company, Fort Carson, CO; Operations Officer, 2nd Transportation Company (HET), Fort Carson, CO; and Battalion Transportation Officer, 68th Corps Support Battalion, Fort Carson, CO. In June of 1999 Colonel Counihan transferred to the United States Army Reserve as a traditional Reserve Soldier (TPU) and served in the following assignments; Battalion S1, 1205th Railway Operating Battalion, Middletown, CT (June 1999 – Oct 2001); Highway Regulation Officer, 719th Movement Control Battalion, Boston, MA (Oct 2001 – Feb 2003) (mobilized in support of Operation Noble Eagle - Aug 2002 to Feb 2003).

NDU), Norfolk, VA (July 2015 – July 2016); Joint Plans Officer, U.S. Africa Command (USAFRICOM), Stuttgart, Germany (July 2016 – June 2018); Executive Officer to the ACAR, Washington, D.C. (June 2018 – June 2021).

Colonel Counihan's civilian education includes a Bachelor's of Science in Physical Education from the University of West Florida; Graduate Certificate (Pre-MBA) in Logistics Management from Northeastern University in Boston, MA; Master in Business Administration (MBA) from Webster University in St Louis, MO; and a Master of Science in Joint Campaign Planning & Strategy from the National Defense University (JAWS).
